

# CORPORATE MATCH

A Corporate Match(ing) Program is an annual monetary donation that your employer may give directly to non-profit 501(c)(3) organizations in order to encourage their employees to give back to their local community.

## What types of matching programs exist?

### MONETARY MATCHING

Employer matches some percentage of the employee's monetary donation

### VOLUNTEER SERVICE

Employer donates a specified amount based on amount of volunteer time

### GRANT

Employer will provide monetary gift based on simply a good cause

### UNITED WAY

Some employers will offer a match only if you participate in their United Way appeal

The IRS has issued a determination letter, effective April 1983, that the Society of Saint Pius X South-West District Inc and its subordinates (i.e. Society of Saint Pius X Kansas City, MO Inc dba St Vincent de Paul Church/Academy) are exempt under section 501(c)(3) of the Internal Revenue Code.

The IRS has furthermore classified the organizations operated, supervised, or controlled by the District (i.e. Society of Saint Pius X Kansas City, MO Inc dba St Vincent de Paul Church/Academy) as organizations that are not private foundations because they are organizations of the type described in sections 509(a)(1) and 170(b)(1)(A)(i) of the Code.

Saint Vincent de Paul Academy maintains a student handbook that states it admits students of any race, color, national and ethnic origin to all the rights, privileges, programs, and activities generally accorded or made available to the students at the school. It does not discriminate on the basis of race, color, national and ethnic origin in the administration of its educational policies, admissions policies, scholarship and loan programs, and athletic and other school-administered programs.
